# 16.2 The following proposal from Exco was accepted – 11 votes in favour:

# Point 2.2.6.1 COMPETITIVE REPRSENTATION

- (b) Any angler, from any division, will have the freedom of association to represent any Association of his/her choice, provided that:
  - (i) Such angler has been affiliated to the new Association of his/her choice on or before 30 April in the year of his/her selection;
  - (ii) The new Association to which he/she affiliated had included him/her in their list of affiliated members submitted to SASAA on or before 30 April of that same year;
  - (iii) The member's annual SASAA affiliation fee was paid in full by the Association to whom he/she nominated for selection by not later than 30 April of that same year;
  - (iv) The member must have fished at least 50 (fifty) percent of the Provincial club leagues

of the new Association; and

- (v) The member must have acquired a one (1) year ranking on a point's matrix system of his/her new Association, which does not include any subjective assessment of the member to be selected.
- (c) A member may only nominate for selection to one (1) Association in any particular angling year.
- (d) A member who nominated and was selected for any Provincial team of any Association, may
- not fish for any other Provincial team of any other Association during the same angling year.
- (e) In the event where an Association decides not to send a team to participate at a National Championship, or withdraws a team from participating at such a National Championship, then any member selected to such a team, shall be allowed to fish for another Association as a "loan" angler, without the restriction imposed on them by Section 2.2.6.1 (d) above.
- (f) A reserve selected to any team participating at a National Championship, shall also be permitted to fish as a "loan" angler without the restriction imposed by Section 2.2.6.1
  (d) above, but only if allowed to do so with the approval of the Executive Committee of his/her own Association, and/or SASAA.
- g) Members who nominated for selection to one Association, but who was not selected for any Provincial team of that Association, may also fish for another Association as a "loan" angler, If allowed to do so with the approval of the Executive Committee of his/her own Association, and/or SASAA.
- (h) In the event of an Association making available to another Association a "loan angler" as mentioned in paragraphs (e), (f) and (g) above, then Sections 2.2.6.1 (b) and (c) above shall not be applicable.

#### Motivation:

To allow anglers / members who are selected by their Associations to compete at a National Championship, but where they cannot participate as a result of a team withdrawal or not enough members in a team, and with the restriction previously imposed on them by Section 2.2.6.1.(d) above.

# 16.3 The following proposal from Exco was accepted unanimously:

POINTS 2.3.1 to POINTS 2.3.5 ANNUAL MEMBERSHIP

- 2.3.1 Annual affiliation fees for individual members are reviewed during the SASAA Annual General Meeting (AGM) as scheduled for JULY every year.
   Individual membership to the association and its members are based on an application and approval basis.
- 2.3.2 The Association's financial year effectively starts on the first day of May, and ends on the last day of April the following year.
- 2.3.3 Each Member Association's affiliation fees to SASAA for the following year's participation is payable on, or before, the last day of April each year.

#### 2.3.4 The SASAA Secretary shall submit the affiliation notice on, or before the last day of February each year accompanied by the membership list template. The Secretary of each Member Association shall submit their membership list for approval and verification of annual affiliation fees due, to the SASAAA Secretary 21 days before the end of April. The SASAA Secretary shall return approved membership lists indicating affiliation fees due to the associations 7 days before the end of April.

2.3.5 Each Member Association's affiliation fee payment shall be accompanied with the proof of payment being submitted to the SASAA Secretary as per point 2.3.3 above.

# Motivation:

- To provide clarity on the issue of membership by ensuring alignment with the SASACC procedure.
- To ensure that the same format membership lists are utilised thereby enabling simplification of the process for further document generation and information requirements.
- To reduce cost by ensuring the correct affiliation fees are paid, thereby reducing additional bank charges being incurred.

In addition to the above group of 18, the 3 top ranked POC's from the Senior A Division shall be included to be considered for selection, of which one (1) must be selected in the Protea team.

The reserve selected for the Protea side will 'automatically' be selected to the President Side. For all other divisions (Grand Masters, U/21 & U/16) the sub group will consist of the 12 top ranked anglers. In addition to the subgroup of 12 anglers in both the u/16 and u/21 Divisions, the top 3 ranked POC's in both (u/16 and u/21) divisions, shall be included in the pool of anglers to be considered for selection. In both (u/16and u/21) divisions at least one (1) POC must be included in the Protea team.

#### To Read:

Based on the 3 year ranking, a subgroup of the 18 top-ranked anglers (Senior A, Masters & Ladies) will be eligible for selection to the Protea and President sides. In addition to the above group of 18, the 3 top ranked **available\_**POC`s from the Senior A Division shall be included to be considered for selection, of which one (1) must be selected in the Protea team.

The reserve selected for the Protea side will 'automatically' be selected to the President Side.

For all other divisions (Grand Masters, U/21, U/16 & FIPS-M) the sub group will consist of the 12 top ranked anglers. In addition to the subgroup of 12 anglers in both the u/16, u/21 & FIPS-M Divisions, the top 3 ranked available POC's in both (u/16, u/21 & FIPS-M) divisions, shall be included in the pool of anglers to be considered for selection. In both (u/16, u/21 & FIPS-M) divisions at least one (1) POC must be included in the Protea team.

#### Action:

The scoring system and selection criteria of the FIPS-M division to be finalised by the newly elected Excom and a SGM be called to approve the proposals thereof.

#### Motivation:

This ensures that our Protea teams are selected in accordance with constitutional requirements and transformation targets are maintained to ensure the availability of Protea colours remains a reality to our members.

#### 16.8 The following proposal from Gauteng North was accepted unanimously:

#### A.2.1.4 Managers and Coaches:

Currently Protea teams management consists of a Manager and a Coach. We propose a change the name of Team Coach to Team Captain.

#### Motivation:

This is to align the descriptions of SASAA's team management to that of SASSACC and SASCOC descriptions of team managers, as to ensure future issues as all management members of National Teams has to attend training as prescribed by SASCOC.

#### 16.9 The following proposal from KZN was not accepted – 9 votes against:

#### Proposal

The B teams sent to the interprovincial to revert back to a 12 man team. With the top six weights counting to the daily team total. All anglers scores to count to their personal rank. **Motivation** 

We feel it is detrimental to the sides from the same Union have to compete against each other, as does happen in the current format.

In the current format there is an advantage to the Unions who send two teams as they are allowed two sets of management on the beach.

The cost per angler is greatly increased when the fixed costs such as guides and vehicles etc are only divided by 6 and the spiralling costs of national tournaments are hindering the development of the sport.

The additional management required for a province to send two teams is also proving to have a negative impact.

It also brings that B team structure in line with that fished in the A division, in terms of numbers of managers and guides allowing for an easier transition for any angler promoted.

The factors that previously motivated the change from a 12 to a 6 man side are no longer a consideration.

It does not disadvantage the smaller unions who are unable to field a 12 man team, and also allows Unions to send any number of anglers from six to twelve. This promotes growth as the unions who have more than six, but less than twelve anglers can send them all.

Amendment to Rule 3. (a) Ladies All Females. All Ages 1 team per Association consisting of: Maximum Ten (10) Nine (9) members: Team manager Coach Six (6) anglers Travelling Reserve Guide Vehicle allocation: Maximum 2 Fishing Periods: Eight (8) hrs but not less than (6) hrs. per day Duration: Three (3) daily sessions **Note:** 

- (a) To create an opportunity for ladies to advance and gain experience at team management level, an angling team member may be nominated as manager exclusively at National Championships tournaments. This has to be clearly indicated on the team sheet, at team registration prior to the Tournament. Only nominated individuals will be allowed to attend meetings where team managers are required. The angling manager may not nominate as:
  - 1) Convener of Selectors
  - 2) Selector
- (b) Only the points of the top Five (5) anglers each day will count towards the team points. All anglers individual points will count towards the anglers SASAA rank points.
- (b) National Team to compete against Namibia. Ladies to fish separate area where possible.
   National Team to participate at FIPS-M World Championships.
   Presidents Team to participate in annual Gus Kollner Tournament. Ladies to fish separate area where possible.

#### CHANGES APPEAR IN RED

#### Motivation

- 1. The Manager/Coaches of the Ladies teams are unlikely to qualify be to participate as a team reserve, if necessary. This means that the reserve should be a travelling reserve.
- 2. The travelling reserve incurs the same expenses as the team and it seems unfair that after all the expense she can only watch.
- 3. There are no real disadvantages to teams not being able to have 6<sup>th</sup> Angler (reserve), as only five angler's scores will count for the team.
- This is line with: (i) an amendment adopted by SASAA SGM on the 3<sup>rd</sup> April 2014 on rule A2.2.1-8 par. changing the composition of the Protea Junior teams to fish against Namibia, except the team remain at 6 and not increase to 7.
  - (ii) the same scoring method used by FIPS-M
- 5. Many of the Provinces are struggling to make up the full compliment of 7 anglers for Ladies' Team, so the reduction of one would greatly assist.

#### 16.11 The following proposal from KZN was accepted – 8 votes in favour:

  - (i) an amendment adopted by SASAA SGM on the 3<sup>rd</sup> April 2014 on rule A2.2.1- 8 par. Changing the composition of the Protea Under 21 and Under 16 teams to fish against Namibia.

(ii) the same method used by FIPS-M

## 16.12 The following proposal from Eden was not accepted – 8 votes against:

Eden Shore Angling would like to propose that Provinces be allowed to send more than one under 21 Team to the Junior Nationals

Our reasons are:

- At the moment Provinces are only allowed to send one under21 team to the nationals.
- Some of the Provinces have very good under 16 anglers and are allowed to send two teams to the Junior Nationals
- When these young anglers are too old for the under 16 teams and are just not good enough to make the under 21 team, as they are competing against men of twenty and twenty one years old for a place in the team, they are left at home and lose their hard earned ranking.
- All our young anglers should be given every opportunity to partake in their chosen sport as this is where our next champions are coming from and not left at home to find a new activity.
- By allowing them to fish in the nationals they keep their ranking and this will motivate them to stay with shore angling and not have to build up a ranking from scratch again.
- SASAA is now promoting the young anglers, i.e. the Schools League, with all these youngsters a bottleneck is bound to develop in the near future.

#### 16.13 The following proposal from KZN was accepted – 9 votes in favour: Amendment to Rule 4 (c) Youth Under 21 Youth U/21 Males & Females.

- 3 There are no real disadvantages to teams not being able to have a reserve as the "seventh" anglers score will not count for the team.
- 4 This is line with;
  - an amendment adopted by SASAA SGM on the 3<sup>rd</sup> April 2014 on rule A2.2.1- 8 par. changing the composition of the Protea Under 21 and Under 16 teams to fish against Namibia
  - ii) the same method used by FIPS-M

# 16.14 The following proposal from Exco was accepted – 9 votes in favour:

# Page 33 Point 5.(a) Development Team

#### Reads:

Only members that have not previously participated in any SASAA sanctioned tournaments, with the exception of youth division members.

#### To Read:

Only members that have not previously participated in any SASAA sanctioned tournaments, with the exception of **Development and Junior** Division members. **It does however not apply to P.O.C. anglers. Motivation:** 

- This ensures that our development and transformation targets are maintained and improved upon.
- It allows the 13<sup>th</sup> angler in the Senior A Division, should he be a P.O.C. to participate in the Development Nationals, thereby improving his skill level through the participation at National level.

• Should a P.O.C. angler as an example be dropped out of the B team of a province due to his ranking position, it will still enable him to participate at National level.

# 16.15 The following proposal from KZN was not accepted – 10 votes against:

- 1. Minimum qualifying weight for edible fish will be one Kilogram(1.0). Points shall be awarded on the base of two [2] points per kilogram and shall be calculated to a portion of a point.
- 2. Minimum qualifying weight for Non edible fish will be two (2) kilogram. Points shall be awarded on the base of one [1] point per kilogram and shall be calculated to a portion of a point.

This is to be applied to all inter-provincial tournaments for Seniors and Masters. Under 21's, Under 16's, Ladies and Grand Masters to remain as is.

**Motivation** – We believe that these tournaments are geared towards good anglers targeting quality fish, the more senior age groups have the ability to target bigger fish and we believe that increasing the minimum weight will make these tournaments more competitive by increasing the number of quality fish caught, and discouraging targeting Of smaller scratching fish. Having a 1 point minimum weight detracts from this as it brings fish like Blacktail and small Lessers into the equation, not necessarily rewarding the targeting of a better fish. We agree that the grand masters, ladies and u16 could benefit from a smaller minimum size as they may not be in a position to catch these bigger fish and they could then target these smaller, more accessible fish.

# 16.16 The following proposal from Exco was accepted – 9 votes in favour:

# Page 38 Point B.5 POINT SCORING SYSTEM

Reads:

12. Scorecards handed in after scales close will not be considered for scoring. Should a team not be able to submit their cards due to an accident or reasons beyond their control they must inform the competition secretary. Each incident will be dealt with on its merits by the Tournament Action Committee.

#### To Read:

- 12. Scorecards must be handed to the designated or nominated person as soon as possible but not later than 90 minutes, or later if so decided at the first captain's meeting, after lines-up.
- 13. Once scorecards are handed to the designated or nominated person it will constitute competition closure for the specific team.
- 14. Scorecards handed in after scales close without prior notification to the Competition Secretary will not be considered for scoring towards the team(s). Should a team not be able to submit their cards due to an accident, fighting a fish after lines up B.6.5 (e), or reasons beyond their control, then they must inform the Competition Secretary without delay. Each incident will be dealt with on its own merits by the Tournament Action Committee who must decide whether the scorecards will be considered for scoring, or not, towards the team(s) and or the individual(s) affected by the late handing in of the scorecards.

#### Action:

Thys Kemp to adapt the SASAA scoring system to accommodate for:

- (a) The possibility that an anglers points will have to accrue as individual and not team point.
- (b) The same has to be catered for in A nationals scoring system as the 13<sup>th</sup> anglers points must only accrue as individual and not team points.

# Motivation:

- Due to current transport mode on the beach being by walking, it allows the anglers sufficient time to reach the scales close area and also allows the time period to be adjusted at Captains meeting ensuring unless due to absolute adverse condition all anglers can comply.
- Nine times out of ten the team management are at fault and it is very unfair to penalize the individual for their mistake(s). We must remember there are president and protea colour at stake here. Where the athlete(s) is at fault the action committee must then also throw out their card(s) for scoring purposes towards the athlete(s).

# 16.17 The following proposal from KZN was withdrawn:

To amend the rule at national competitions to address the following:

If an anglers weight card is refused due to being submitted after scales are closed, the weight is deducted from the team total but the weight will still be added to the anglers' individual total for the tournament. **Motivation**. An angler does not get penalised for three years by no fault of their own

# 16.18 The following proposal from Exco was accepted unanimously: Page 39 Point B.6.2 Terminal Fishing Tackle

# Reads:

# 17. Discussion of, and or voting on special issues:

# **17.1** The following proposal from Gauteng North was discussed, but not accepted – 10 votes against Herewith are our Union's proposal for the SASAA's forthcoming AGM:

# Commission for World Championships tournament convener and work group.

We propose that a commission is paid to the SASAA FIPS-M world championship tournament convener and work group and that the amounts are established at the AGM as is done with the SASAA secretary and treasurer.

#### Motivation:

It is important that the SASAA tournament convener and the working parties for FIPS-M world championship events are appreciated as arranging tournaments on this scale takes huge effort. FIPS-M tournaments in South Africa are financially beneficial for SASAA as the monies are utilized to support selected SASAA teams. Dividing the commission between all parties involved will further the commitment of individuals (such as weigh officials, etc) for future tournaments.

#### Possible suggestion:

- A 5% commission (after tournament expenses are paid) to be paid to tournament convener).
- A 2% commission (after tournament expenses are paid) to be divided between the work committee (exclusive of the tournament convener).
- A 2 % commission (**before** tournament expenses are paid), (based on total for entrance fees) to be made available to the weigh officials for the tournament. (This amount could be estimated prior to the tournament in order to establish a budget and source weigh officials).
- A 1% commission (after tournament expenses are paid), to be paid to West Coast Shore Angling Association.

# 17.2 The following proposal from Exco was discussed and unanimously accepted:

**Conflict of Interest** must be an Agenda point for Divisional ADM's and the attached – **ANNEX R**: **CONFLICT OF INTEREST DECLERATION** must be signed by persons appointed or selected into positions which could create a conflict of interest situation.

#### Motivation:

To ensure that all members are made aware and reminded that any potential Conflict of Interest must be declared.

To ensure that any possible dispute / grievance is avoided where any potential Conflict may exist.

# **17.3** The following proposal from Gauteng North was discussed and accepted – 8 votes in favour: Herewith are our Union's proposal for the SASAA's forthcoming AGM:

# Selection of Dates for Senior A Nationals

We propose that the dates selected do not fall over last week of February but propose that the Senior A Nationals rather be fished early March of each year.

# Motivation:

The last day of February being 28/29 is financial year end for 95% of all South African Registered Companies and a lot of our anglers are self-employed business people or employed in senior positions within companies making it very difficult or impossible to take leave to attend the Nationals.

# 17.4 The following proposal from Eden was discussed and accepted – 6 votes in favour, none against: Eden Shore Angling would like to propose that the Junior Nationals for 2017 to be hosted by Eden Shore Angling be held from 30 January 2017 to 2 February 2017 and not at the same time as the Masters tournament.

Our reasons are:

- The Masters Nationals is to be held from 24-26 January 2017
- The following members are in our Masters team; Thomas Heath Manager, Johann Strauss, Hennie Kleyn, Nico Lesch, Peet Mey, Tersius Baard as anglers
- The above members are all an integrate part of the Junior Nationals. T Heath President of Eden, J Strauss Convenor, H Kleyn Bait supplier, T Baard secretary of the Junior Division and Team Manager, P Mey and N Lesch in charge of Weigh Officials, Life savers and assisting with the points.
- All the above should not be denied the right to participate in the Masters Nationals just because they are willing to help with the running of a SASAA Tournament
- By not being allowed to partake in the Masters Nationals they will lose their ranking, not have the opportunity to be selected for the SA Masters Team and Eden not able to field their strongest team at the tournament. These members have worked hard to make the Eden team and should be given the opportunity to be at the Masters tournament
- Eden has for more than ten years been affiliated to the local Sport Council and to the Western Cape Local Government Department of Sport. They have in the past five years allocated more than R100000.00 to Eden to host National Events. The 2017 Junior budget is more than R2000.00 per team cheaper than 2016 as a direct result of the funding from DCAS.
- Because the Department of Sport is closely involved with us during the tournaments and attend meetings and the prize giving, they have seen that we set high standards, that we have met our targets on the Transformation Score Card and that we have always had clean audits, they have supported us finically.
- Taking into account the reasons as above, and should the members of our Masters Team decide to fish the Masters tournament, which they have all the right to do, we do not at this stage want to spoil our good standing with DCAS by not having the right people at the tournament, resulting in a termination of the funds in future.
- We stand to be corrected, but we are not aware that the dates for the nationals are set out in the SASAA Constitution. We thus ask that this request be granted by SASAA at the AGM.

#### 17.5 The following issue from Gauteng North was discussed and it was agreed that decisions made at the AGM must be adhered to in future: FIPS-M/RASSPL

It is decided that a new facet, Match Angling, must be introduced under SASAA per SGM. D Lucas will manage the process.

All provinces must in future be able to attend a tournament where this style of fishing be fished as part of the process to select a Protea team to attend the world championships.

RASPPL team may be invited should they affiliate to SASAA. New SASAA exco must take up the changes, as proposed by SASACC, with RASPPL.

# 17.6 The following issue from Gauteng North was discussed, SASAA explained and apologised that due to time constraints and availability of people, the meeting did not take place. GENERAL MEETINGS

The following proposal from the exco **was accepted** unanimously:

The **South African Shore Angling Association** shall hold at least two General Meetings of Members during a calendar year, of which one shall be the Annual General Meeting.

# 17.7 The request from the Protea Junior u/16 manger for subsidy for the P.O.C. team member was discussed:

The request was not accepted.

# 17.8 The following proposal from Exco was accepted – 7 votes in favour: PROPOSAL:

Namibia proposed that the events be fished in Namibia permanently. Cost to be split & countries take turns in hosting the International in Namibia. Trial for one (1) year and to be reviewed in 2018. **MOTIVATION:** 

Beach access available to all parties.

# 17.9 The following proposal from Exco was accepted – 7 votes in favour:

Because there is doubt about the feedback from the various divisions, Pierre said that division's area again to make sure at their ADM's where they want to fish so that the matrix can be adjusted accordingly. Only if there are is consensus about where divisions really want to fish we can submit the matrix for final approval. This matrix is only temporary until next year after which it will be adjusted finally for 8 years.

# PRESIDENTS REPORT ON SASAA FOR 2015 - 2016

On behalf of the SASAA Executive committee we would like to thank all Provincial Presidents, their committee's and members for the great spirit in which the previous season was conducted.

# Highlights and events for 2015 - 2016 angling year were:

# 1. SASAA 2015 WORLD CLUB CHAMPIONSHIP

SASAA hosted the FIPS-M World Club Championship tournament in November 2015 in Langebaan. The top three positions were raked in by the more experienced European teams with South Africa obtaining a 5<sup>th</sup> position out of the 19 teams participating. The tournament was a showpiece in international standards. SASAA / Westcoast will be hosting the World Shore Angling Championships for ladies and Senior men's divisions in November 2017.

Match angling is becoming a very popular facet amongst our members. Dirk Lucas has spearheaded this facet and trials were fished in April 2016. All Provinces were invited to enter a five man and five lady team to the trials to enable the individual members to build up ranking for the following three years in this facet. Protea teams will be selected from trials attendees to participate in the locally fished 2017 World Shore Angling Championships

# 2. SASAA SCHOOLS PROGRAMME

SASAA wish to thank Deon Goch, his assistants in WCSAA for the successful 2015 Schools League tournament. Westcoast, WP, Boland, Eden and Natal have instituted this league. This has introduced 100's of youth POC's to Shore Angling. EP will be assisted in the upcoming season to launch a School League to attract our youth.

The success story in this initiative lies in a POC angler named Alricht Gelderbloem who resides in "Power Town", an informal settlement in Klein Brak was included in Eden Provinces u/16 School League team and participated in the Western Cape Schools League tournament in December 2015. During the national championships Alricht Gelderbloem ended 10<sup>th</sup> amongst experienced anglers and deserved to be included in the **u/16 Protea team** to fish an international tournament against Namibia.

- SASAA wish to thank SASACC for the funding made available Develop and introduce shore angling to school children and particularly to disadvantaged children from rural areas. The five Provinces involved with this project are Westcoast. Western Cape, Boland, Eden and Natal
- More than 130 boys and girls from previously disadvantaged communities participated in the Schools Mini League competitions. Each Province will select 6 anglers to represent their Province at the 2016 Junior Nationals tournament.

- iii. Despite decline in membership SASAA is increasing youth membership into the well accepted Schools Mini League.
- v. SASAA must continue to grow the sport amongst our youth in schools and underprivileged areas. In this way we improve the future existence of our sport and contribute to society by teaching the youth to respect and appreciate our natural resources.

All divisions, namely, Senior A, Senior B, Development, Juniors, Ladies, Masters and Grand Masters tournament were fished from November 2015 to March 2016. # 5. INTERNATIONAL COMPETITIONS

- i. SASAA has selected Ladies and Men's Protea teams to participate in the FIPS-M World Shore Angling Championships to be fished in Ireland November 2016,
- ii. Furthermore Senior A, Juniors, Ladies, Masters and Grand Masters teams were selected to fish against Namibia in December 2016. Well done to all participants and we trust you will be true ambassadors for our sport and South Africa.

# SASAA – Treasurer's Report for the year ended 30 April 2016

- 1. Financial Performance:
  - <u>Affiliation fee</u> income decreased by 12% year-on-year as a result of a decrease in affiliated members by also 12% (241 members).total affiliated members now 1773 [Note: figures quoted represent "paid-up" members and exclude U16 and associated members];



- Net income from tournaments increased by R55 000, mainly as a result of sponsorships received for tournaments shirts;
- SASAA hosted the 2015 World Club Championships in Langebaan and due to a huge effort from Frans Claassen realised a net profit of R250 000;
- Income from investments was a positive R40 000 despite adverse market conditions;
- Contributions to FIPs-M World Championships Protea teams was approved at a flat R50 000 for each of the ladies and men's teams;
- A very successful and top-class hosting of the annual RSA vs Namibia tests cost SASAA R87 000 due to excellent planning and the R2 500 contribution per angler;
- Costs incurred towards the resolution of the KZN angler disputes amounted to R36 000;
- SASAA contributed R15 200 towards various transformation/development initiatives and further distributed R72 000 received from SASACC towards junior development initiatives (with a further R178 000 still to be distributed in the new financial year).

# **ENVIROMENTAL OFFICER REPORT**

The position of Environmental Officer at SASAA was established at the end of 2005 when beach access was restricted by new Legislation. Since then, applications were made annually for National and Provincial angling competitions as agreed with the Department.

Two International events were also applied for and approved with great success, this excludes the International events between SA and Namibia in our coastal waters.

Over the 11 years, bridges were built, and SASAA developed a good strategy which assisted greatly in obtaining beach access permits for all applications lodged for the total coast South African coast. Our inputs at the Public Forum at Sea Fisheries also proved valuable and relationships built over time.

With the demise and changing of Government departments, the approval processes slowly started becoming more complex and at times a serious challenge to obtain the approved permits. Over time though, positive relationships ensured that certain coastal areas were earmarked for approval, and became formally known as SASAA's competition areas in the coastal provinces. This created a secure environment were angling prospered competition wise, and we were confident that the future was paved. Both environment, public and the angling fraternity benefitted.

Legislation changed in June 2014, and the new Act stipulated that for beach access permits and Environmental Plan for each application (and area) had to be submitted. The process proved to be lengthy, costly and rallied with red tape, which terminated the applications for 2016 due to these factors. The Department stressed that they do not require an Environmental Impact assessment, (EIA) but a much simpler Plan, and will assist SASAA on all levels to obtain approvals.

On submission of the Plan, the Department assistance proved the contrary and the report was inundated with red tape requirements, further public processes etc. The application was sadly retracted, and the negative impact on the International competition between RSA and Namibia severely felt.

It is with sadness that I tender my unavailability for the Environmental Officer for the next term. My resources to compile the applications and skills have become limited, and my successors' task one that will require new skills.

# SASAA HEAD COACH REPORT 2015/2016

During the 2015 SASAA Annual General Meeting in Cape Town I was appointed the Head Coach. This was a new position on the committee that on instruction from our Federation SASACC had to be filled. During the AGM, which was also attended by the SASACC Secretary Andries Maree, SASAA was informed that all future Protea Coaches had to attend a level one training course that will be hosted by SASACC at different venues in different provinces.

The successful completion of this course will be a prerequisite for selection for a Protea Team. The same will apply for Managers and Coaches. I attended this Coaching Course in Johannesburg during July 2015 while 48 other SASAA members attended/was supposed to attend during the latter halve of the year. The provisional results that were release indicated that only 8 members that attended, passed the Course. This is a worrying factor taken into consideration that the successful completion of this Course will be compulsory from 2017 for selection of Protea Coaches.

It also appears to me that very few Associations affiliated to SASAA had the position of Coach on their Provincial Committees filled. During these Coaching Courses and after the completion thereof Andries Maree requested input from the different facets of angling to complete a Coaching Level 2 training manual. This request was send out by the SASAA Secretary to all the associations for feedback before the 15th December 2015. By the 15th December not one of the Associations had given any feedback to either myself or SASAA. Andre Stevens discussed the matter with Andries Maree from SASACC. The outcome of the discussions is unknown to me.

Lastly I would like to comment that during my involvement as manager of the Protea Men's Shore Angling Team since 2008 the best coaches are the 'old'/past Protea Anglers. Due the nature of the sport of angling most of these anglers are currently still actively involved in angling either as Masters or Grand Masters. I call on all the Associations to get these anglers involved in there coaching programs. I need feedback from the associations because it will not be possible to do this on my own.

Hope the new SASAA Committee get the support from everybody and I wish them well.
